

**Harper Lake Membership Meeting**  
**August 18, 2012**  
**9:00 am**

Meeting was called to order at Irons Union Church by Dick Blumenstein at 9:07 am.

**Secretary Report**

The minutes from the May 26, 2012 meeting were approved by the membership. Donna Kott motioned to accept with Sue Oleneack second. All were in favor.

**Treasurer Report**

Lisa Mullen presented the 2012 budget report. Three more members paid their dues which makes the count for paid members at 90. The ending balance as of 8/16/2012 is \$15,490.21. Jim Abbott made a motion to accept the report and Nancy Randall second. All were in favor.

**Asian Milfoil Treatment**

On June 18, 2012 about 2.5 acres were treated for milfoil. The actual cost for this treatment was \$1020 plus \$400 for the permit. It was brought to the membership's attention that weeds have increased but this was going to be discussed under new business later in the meeting.

**Dredging Project Update**

The dredging depth of approximately 6 feet has been completed. There was a reminder that the cut was not made all of the way through. It was made just for the homeowners to get in and out of their dock areas. Please inform the homeowners not to try and go through this side of the island. You will get stuck as before and you will also cause the silt to get stirred up and possibly undo some of the dredging that was done. The markers will be kept up this year but hopefully will be able to be removed for next summer lake season.

**Committee Reports**

**HLA Website**

We had a show of hands and it was decided that the fall meeting would take place on Saturday, August 31, 2012.

### **Newsletter**

Kathy Abbott reported that the Harper Lake picnic held on July 21, 2012 had approximately 45 members attending. She also stated that maybe it was time to rethink the picnic possibilities. Having the picnic along with the Poker Run was a possibility or maybe a hot dog cookout on pontoons out on the lake. A committee will be formed to come up with some ideas on how to improve attendance for this Harper Lake Association event.

### **Fish Planting**

It seems as if the fish that we have previously planted seem to be growing. Members have reported that they are catching some larger sized fish above 35 inches.

### **Weed Control**

The weeds seem to be bad this year. Dick Blumenstein reported that it was probably due to the lack of snow and ice cover and the extreme heat. What can be done? Dick has looked at two different groups who could help with this situation. One is Aqua Doctors and the other is PLM. We can enroll in a three year contract with either one. They could evaluate the weed situation for us and then come up with a treatment plan to control the weeds, good and bad ones. This evaluation would include a complete survey of the lake, they would map it out and then produce a plan. We have used PLM in the past but Dick has not been that impressed with the new crew out of Ewart. Aqua Docks seems to be a little cheaper. They both use the same chemicals for the control. They would get us a good balance of weeds for the fish plantings. It was suggested that we should establish a baseline and then proceed. Since we do not have a problem of Gypsy moth, we could divert funds to the weed control budget to pay for the weed control evaluation.

### **Water Quality**

Does the water quality test include testing of chemicals, etc? It is assumed it has been done just for clarity which does not seem to be a problem. Dick Blumenstein will look into this and decide if another testing should be done to check other problems.

### **Geese Situation**

We do have geese on the lake that like to come up on the homeowner's properties and docks. Dick Blumenstein has checked into this and there seems to be a catch and release program for certain areas if we are interested. Other suggestions were letting off bottle rockets and big red flags put on the end of your dock. The May family has used the flag idea which seems to help. They can be contacted if anyone is interested in this idea.

### **Poker Run**

Fletcher MacGregor reported that the Poker Run was a huge success this year. Howie Mullen and Jim Abbott came up with a new idea for this event and will continue with it for next year. Jim Abbott stated that the property between his house and Roger Zeh's would probably be the location for 2013. At the meeting, the following members offered to be dock captains: Humfleets, Mays, Kotts, Blumensteins, Badallucco and Randalls (if needed). If you are interested in being a dock captain, please contact one of the board members.

### **Gypsy Moth**

There is not a problem at this time. If a problem is noticed, we could ask the USDA to come out and evaluate the areas free of charge. Jim Hickey, who was the head of the Gypsy Moth situation chose not to return to the board because of health issues. We would like to thank him for all of his years of service on the Harper Lake Association Board.
